Our Organization conducted an Awareness Programme on Consumers by specific instruction on consumer right of the people. Besides our Organization also conducted a Programme on Preservation of Rare Books and Manuscript to preserve the ancient Historical Manuscript of Literature.

Moreover, Our Organization conducted a Welfare Programme for Street and Working Children. This is an Intregrated Programme for the Children without Homes and Families. It is based on cardinal principles of "Protection of Child Rights" and that the "Best interest of the Child". Hence to the reduction of vulnerabilities to situation and actions that lead to abuse, neglect, exploitation, abandonment and separation of children. These will be achieved by :

- (i) Improved access to and quality of Child Protection Services,
- (ii) Raised Awareness about the reality of Child Rights.
- (iii) Clearly articulated responsibilities and enforced accountability for Child Protection.

This Programme for Children is associated with Domestic Child Labour, Working at Dhabas, Mechanic Shops etc. The expected Outputs of the Programme will be focused on :

- (i) Preparing Child protection plans to the community levels.
- (ii) Strengthening knowledge base Education, Awareness and Advocacy.
- (iii) Improving access to and quality of Service Provider.
